POCKET TRADER PRIVACY POLICY

Pocket Trader is committed to ensuring that your privacy is protected. Our privacy policy explains how we use the information collected and the procedures which Pocket Trader has in place to safeguard your privacy.

Information collected by Pocket Trader and How it is Used

If you choose to provide us with personal information, you are consenting to Pocket Trader's collection, use, disclosure of your personal information and to the transfer and storage of that information.

Pocket Trader collects and stores the following personal information:

- email address, phone numbers, physical contact information, and financial information, if required;
- computer sign-on data, statistics on page views, traffic to and from Pocket Trader and ad data;
- other information, including users IP address and standard web log information.

Pocket Trader uses your personal information to:

- collect subscription fees;
- provide services;
- improve your use of Pocket Trader;
- deal with problems;
- dispute resolution;
- deliver targeted marketing and promotional offers to you according to your preferences;
- do other things for users as described when Pocket Trader collects the information.

If you submit content for publication, you acknowledge that Pocket Trader may publish the information which you have provided.

Information Sharing and Disclosure of Personal Information

Pocket Trader may disclose personal information in order to enforce its policies or to deal with any legal requirement. You acknowledge that Pocket Trader may share personal information with third-party websites and publishers and to service providers who assist in operating the Pocket Trader but Pocket Trader will require them to protect the information in a manner consistent with this privacy policy.

Cookies and Web Beacons

Pocket Trader uses Cookies and similar technology. Cookies are small text files placed on your computer by web sites. A cookie contains identifying information. The cookie is used to link between you and the information which you have provided.

POCKET TRADER TERMS OF USE

Pocket Trader Terms of Use

General

By using the Pocket Trader you agree as follows:

- these terms set out the terms and conditions that apply to your use of the Pocket Trader.
- by using the Pocket Trader, you acknowledge that you have read, understood and agree to be bound by these terms.
- the right to use the Pocket Trader is personal to you and not transferrable.
- you are responsible for your use of the Pocket Trader and ensuring that your use complies with these terms.

Conduct

- (a) You will only use the Pocket Trader for lawful purposes and not violate any laws.
- (b) You will not use nor permit to be used the Pocket Trader by any robot spider, scraper or other automated means to access Pocket Trader and collect content for any purpose without Pocket Trader's express written permission.
- (c) You will not infringe any third-party rights or intellectual property rights.
- (d) You will not distribute spam, chain letters, or pyramid schemes.
- (e) You will not distribute viruses or any other technologies that may harm Pocket Trader or the interests or property of Pocket Trader users.
- (f) You will not interfere with the proper working of the Pocket Trader.
- (g) You will not copy, modify, or distribute any other person's content without their consent.
- (h) You will not collect information about others, including email addresses, without their consent.
- (i) You will not bypass measures used to prevent or restrict access to the Pocket Trader.
- (j) You are at least eighteen (18) years of age.

Pocket Trader cannot guarantee error-free, continuous or secure access to the Pocket Trader or that defects will be corrected.

Pocket Trader may update these Terms at any time, with updates taking effect when you next use the Pocket Trader or 30 days after the terms are incorporated on the Pocket Trader, whichever is sooner. No other amendment to this agreement will be effective unless made in writing, signed by you and Pocket Trader.
